DURING THE COVID-19 PANDEMIC, WE LIMITED CLASSES TO TUESDAY AND THURSDAY ONLY DUE TO LOW STUDENT ENROLLMENT DURING THAT TIME. CHILDCARE IS TYPICALLY AVAILABLE DURING ALL CLASS TIMES, HOWEVER DURING THE PANDEMIC, WE DID NOT OFFER CHILDCARE SINCE WE HAD NO IN-PERSON CLASSES. THE COMPUTER LAB IS STAFFED 12 HOURS PER WEEK, BUT AVAILABLE FOR STUDENTS TO WORK INDEPENDENTLY DURING ALL BUSINESS HOURS. OBJECTIVE: TO PROVIDE ENGLISH LANGUAGE LEARNING AND CRITICAL THINKING INSTRUCTION TO ENABLE LEARNERS TO BECOME ENGAGED, SELF-SUFFICIENT PARENTS, EMPLOYEES AND COMMUNITY MEMBERS. OVER 400 ADULTS ARE ENROLLED AND ATTENDING ONE OF THE 4 LEVELS OF ENGLISH CLASSES. CLASS STUDENTS ARE REASSESSED AT THE END OF
