

STUDENTS ATTEND CLASS TWICE PER WEEK FOR 2 HOURS PER CLASS. DURING THE COVID-19 PANDEMIC, WE LIMITED CLASSES TO TUESDAYS AND THURSDAYS ONLY DUE TO LOW STUDENT ENROLLMENT DURING THAT TIME. WE RESUMED IN-PERSON CLASSES IN AUGUST 2021. CHILDCARE IS OFFERED DURING ALL CLASS TIMES, HOWEVER DURING THE PANDEMIC WE DID NOT OFFER CHILDCARE SINCE WE HAD NO IN-PERSON CLASSES.
